

## Arlon Graphics, LLC Rebate Offer - Terms & Conditions

1. **REBATE DESCRIPTION:** The Arlon FLITE Offer Promotion ("Rebate Offer") begins on February 16, 2023 and ends at 7:00 P.M. AEDT on June 30<sup>th</sup>, 2023 (the "Promotion Period").
