

Arlon Graphics, LLC Cash For Cast Cashback Offer - Terms & Conditions

1. CASHBACK OFFER DESCRIPTION: The Arlon Cash for Cast Promotion ("Cashback Offer") begins on October 16, 2023 at 12:00 A.M. EST and ends on December 15th, 2023 at 11:59 P.M. PST (the "Promotion Period"). The sponsor of the Cashback Offer is Arlon Graphics, LLC ("Sponsor"). Participating in the Cashback Offer requires unconditional acceptance and compliance with these Terms & Conditions as determined by the sole discretion of the Sponsor, which shall be final and binding in all respects. The Cashback Offer cannot be combined with any other offer and is not valid where prohibited by law.

2. ELIGIBLE PURCHASES: "Eligible Purchases" are standard sized rolls (54 inches or 60 inches wide and at least 50 yards long) only and must include the purchase of **both** a "Qualifying Print Media" defined as SLX+ (all finishes and constructions), SLX Cast Wrap (all finishes and constructions), or DPF 6100XLP (all finishes and constructions); **and** a "Qualifying Overlaminates" defined as Series 3200 Overlaminates (all finishes), Series 3210 Overlaminates (all finishes), Series 3220 Overlaminates (all finishes), Series 3270 Overlaminates (all finishes), or Series 3310 PVC-Free Overlaminates (all finishes). No other products, including customized sizes or finishes, qualify for the Cashback Offer.

3. ELIGIBLE PERSONS: The Cashback Offer is valid only for Purchasers as defined in Paragraph 4 who are residents of the United States or Canada and who make Eligible Purchases from authorized Arlon Distributors located in the United States during the Promotion Period.

4. DEFINITIONS OF PURCHASER AND ENTRANT: A "Purchaser" includes a corporation, company, partnership, firm, association, organization, business trust, society, or natural person. A Purchaser that submits a valid Submission as defined in Paragraph 5 within the Promotion Period is an "Entrant."

5. CONTENT OF SUBMISSIONS: For an Entrant's submission to be valid, it must contain all the information set forth at <https://info.arlon.com/cashforcast> and as further described at https://7322308.fs1.hubspotusercontent-na1.net/hubfs/7322308/FY24_NAT_CFC_Invoice%20Example.jpg (the "Submission"). Specifically, there must be proof of

- A purchase date between October 16, 2023, 12:00 A.M. EST and December 15, 2023, 11:59 P.M. PST;
- An invoice number;
- A purchase order number; **and**
- A purchase order that proves the valid purchase of at least one kit featuring one Qualifying Print Media **and** one Qualifying Overlaminates as set forth in Paragraph 2.

Failure to provide all required information or complete all necessary steps will prevent Cashback approval.

5. ADDITIONAL SUBMISSION REQUIREMENTS: A Purchaser can make Submissions until 11:59 P.M. PST on December 22, 2023 (the "Submission Deadline"). Sponsor is not responsible for lost, late, incomplete, or undelivered Submissions.

6. CASHBACK OFFER TERMS: The Cashback Offer applies only to Eligible Purchases and valid Submissions during the Promotion Period. The Entrant may submit multiple Submissions or multiple invoices from different purchase orders in one Submission during the Promotion Period. All of the cashback amounts are subject to a maximum total combined cashback value of USD 900 or equivalent local currency per unique Entrant, meaning that if multiple Entrants within a Purchaser make Submissions, each Submission will be considered a combined Submission accruing to the Purchaser rather than individual Submissions accruing to each Entrant. Cashbacks cannot be transferred or substituted.

7. CASHBACK OFFER BREAKDOWN: The Cashback Offer breakdown for Eligible Purchases is as follows

- \$60 cashback per kit with the purchase of 1-3 kits

Sponsor will add a bonus of \$50 cashback per kit when an Eligible Purchase is paired with the Series 3310 PVC-Free Overlaminated standard sized rolls (54 inches or 60 inches wide and at least 50 yards long) and all finishes.

8. CASHBACK OFFER PAYMENT: The Cashback amount will be paid in the local currency. Sponsor has the exclusive right to determine the currency conversion rate, which may be revised from time to time, at Sponsor's sole discretion. Cashbacks will only be paid electronically, via PayPal® or eGift Card, whichever the recipient selects. (This Offer is not sponsored, endorsed, administered by, or associated with PayPal® or any eGift Card distributor.) Cashbacks paid via PayPal® or eGiftCard will be confirmed via email. Payments will start being sent out 12 (twelve) business days after the Submission Deadline. A valid PayPal® account is required to receive payment through PayPal®. The Entrant is responsible for having a valid PayPal® account capable of receiving Cashback payment from Sponsor. When accepting payment via PayPal®, Entrants may be subject to third-party data policies, terms of use, and/or third-party fees, including but not limited to fees charged by PayPal®. Entrants selecting PayPal® as the desired payment option will only receive Cashback via the PayPal® account identified in the Submission. If Entrant "opts-in" to receive information about the Sponsor's events, products, and services at the time of Submission, Sponsor may use the Entrant Information to provide Entrant with information about the Sponsor's events, products, and services, including via post, telephone, email, and SMS, and may disclose Entrant Information to third parties. Entrant may advise Sponsor at any time if such information about events, products, and services is no longer welcome by contacting the Sponsor using the contact details available at https://www.arlon.com/na_en/legal/global-privacy-policy-na-en. Sponsor may continue to provide Entrant with this information until advised otherwise by Entrant.

Sponsor and Sponsor's associates—including but not limited to entities controlled by the Sponsor, Sponsor's affiliates, and third parties doing business with Sponsor—may be located in areas other than the United States or Canada. As a result, Entrant Information, including personal information collected and held by Sponsor, may be transferred to locations in areas other than the United States or Canada.

SPONSOR'S RESERVATION OF RIGHTS: Sponsor reserves the right in its sole discretion to suspend or terminate the participation of any Purchaser or Entrant in the Cashback Offer program if there is activity that it believes to be abusive, fraudulent, in violation of any law, and/or does not comply with the Terms & Conditions. Sponsor may in its sole discretion unilaterally amend these Terms & Conditions or cancel, terminate, modify, or suspend the Cashback Offer program for any reason and without notice in whole or in part.

LIMITATION OF LIABILITY: Sponsor assumes no responsibility or liability at any point in the operation of the Cashback Offer for any incorrect or inaccurate Submissions or for any faulty or failed electronic data transmissions; any unauthorized access to, or theft, destruction or alteration of entries; any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure regardless of cause with regard to any equipment, systems, networks, lines, satellites, servers, camera, computers, or providers utilized in any aspect of the operation of the Cashback Offer; inaccessibility or unavailability of any network or wireless service, the Internet or Web site or any combination thereof; suspended or discontinued Internet, wireless or landline phone service; or any injury or damage to Purchaser's, Entrant's or to any other person's computer or mobile device which may be related to or resulting from any attempt to participate in the Cashback Offer or download of any materials related to the Cashback Offer. CHOICE OF LAW AND VENUE: These Terms & Conditions and all claims relating thereto, including any dispute or claim arising out of their subject matter or formation (including non-contractual disputes and claims), shall be governed by the substantive and procedural laws of the State of California without regard to conflict of laws and all claims arising out of or related to the Terms & Conditions shall be resolved solely and exclusively in the State of California. The United Nations Convention on Contracts for the International Sale of Goods shall not apply to the Cashback Offer.
