

'Arlon's Cashback Offer' Promotion

1. **PROMOTION DESCRIPTION:** The Arlon Cashback Offer Promotion ("Cashback Offer") begins on 1 July, 2022 and ends at close of business day on 31 August 2022 (the "Promotion Period").

The sponsor of this Cashback Promotion is Arlon Graphics, LLC ("Sponsor"). By participating in the Cashback Promotion, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Sponsor is responsible for the collection, submission or processing of rebate submissions and the overall administration of the Cashback Promotion. Entrants should look solely to Sponsor with any questions, comments or problems related to the Cashback Promotion.

2. **ELIGIBILITY:** Open to legal residents of Australia and New Zealand (the "Entrant"). This Cashback Promotion is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.

3. **CASHBACK:** A \$20 Cashback ("Cashback Amount") will be provided to the Entrant upon successfully submitting between 1 July 1 – 31 August 2022, a contact form and uploading a valid proof of purchase on select rolls of Arlon media purchased by the Entrant during the Promotion Period. The Cashback Amount will be paid in the local currency. The products that qualify for this Cashback Promotion are DPF 510 (all finishes and constructions), DPF 4550 (all finishes and construction), Series 3450 Overlaminates (all finishes), and Series 3510 (all finishes). All products must be 1.37 meters or 1.52 meters in width and 45.72 meters in length. To qualify for any of the cashback offers, entrant must provide proof of purchase from an authorized Arlon distributor in Australia or New Zealand. No other Arlon films qualify for this Cashback Promotion. Participant must purchase quantities, widths, and lengths outlined in the Cashback Promotion. Mix and match of products to achieve the maximum rebate payout is permitted.

Limit twenty (20) cashback payouts per person and per business entity will be honored during the promotion period (maximum cashback value of \$400 in local currency). Cashback cannot be transferred or substituted by participant.

Cashback payment will be provided to participant in the form of an electronically paid rebate ("E-Rebate") via PayPal. Allow up to 7 business days for payment to be sent to participant. An Arlon representative will email participant if an incomplete or non-complying submission is received. This may delay participants the timeframe in which participant receives the cashback payment.

This Cashback Promotion is open to legal residents of Australia and New Zealand and Rebate will only be paid through the PayPal account holders stated in the cashback submission form. The email and/or phone number must be associated with the PayPal account. Fraudulent submissions will not be honored. Failure to comply with the Official Rules will result in forfeiture of the cashback.

4. **ELIGIBLE PRODUCTS:** DPF 510 and DPF 4550 (all finishes and construction), Series 3450 Overlaminates (all finishes), and Series 3510 (all finishes). All products must be 1.37 meters or 1.52 meters in width and 45.72 meters in length. Entrant can purchase two (2) rolls at 22.86 meters in length to make up the length of one roll at 45.72 meters in length, however the purchase of the two rolls must be shown on the same proof of purchase. Participant must purchase quantities, widths, and lengths outlined in the Cashback Promotion through authorized distributors in Australia and New Zealand.

5. **HOW TO ENTER:** A purchase of eligible products from an authorized Arlon distributor in Australia or New Zealand must be made within the promotion period in addition to submitting a contact form in order for the cashback submission to be valid. Submissions are accepted through the dedicated landing page. After Arlon has received entrant's submission, Arlon will notify entrant via email confirming receipt of the cashback form. Arlon will take up to 7 business days to

review cashback submission form. Upon review and confirmation of cashback submission form, Arlon will issue rebate payment via PayPal within 24 hours. Once Arlon has issued the cashback payment, the entrant will receive an email notifying that Arlon has issued the cashback.

6. **PRIVACY:** The Sponsor collects the personal information of Entrants for the purpose of conducting the Cashback Offer promotion. The information collected includes the Entrant's name, email address, and the name of their employer. The Sponsor may disclose this information for the purpose identified above to agents engaged by the Sponsor. If Entrants do not provide the personal information requested, they will not be able to participate in the Cashback Offer promotion.

If Entrants "opt in" to receive information about the Sponsor's events, products and services at the time of entering the Cashback Offer promotion, the Sponsor may use the Entrant's personal information to provide the Entrant with information about the Sponsor's events, products and services (including via post, phone, email and SMS), and may disclose the information to its related bodies corporate, and to contractors (including call centres, advertising agencies and direct mail houses) the Sponsor engages for that purpose.
